I, Shubham Ranjan Sinha, Practising Company Secretary (ACS-69409/ CP - 26884) and proprietor of M/s. Shubham Sinha & Associates, Company Secretaries, was appointed by the Board of Directors of the company as Scrutinizer to scrutinize the e-voting process pursuant to section 108 of the Companies Act, 2013 read with Rule 20(4)(ix) of the Companies (Management and Administration) Rules, 2014 and the provisions of Regulation 44 of the Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulations, 2015 to scrutinize the electronic voting (Remote e-voting) and the poll process for the resolutions contained in the notice of Extra-Ordinary General Meeting ("the Meeting") of the Company, submit my combined report as under:

The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013, MCA Circulars and the Rules relating to remote e-voting and e- voting at the EGM on the resolutions contained in the Notice of the EGM dated the 27th day of March, 2025. My responsibility as a scrutinizer for remote e-voting and voting at the EGM is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolution, based on the reports generated from the e-voting system of National Securities Depository Limited ("NSDL"), the agency engaged by the Company to provide the facilities for remote e-voting and voting by poll at the EGM. I submit my report as under:

- 1. The remote e-voting period remained open from 09:00 A.M. IST on Monday, the 24^{th} day of March, 2025 up to 5:00 P M. IST on Wednesday, the 26^{th} day of March, 2025.
- The shareholders holding shares as on the "cut-off date" i.e. Wednesday, the 19th day of March, 2025 were entitled to vote on the proposed resolutions as mentioned in the Notice of the EGM dated the 27th day of March, 2025.
- 3. At the end of the remote e-voting period on Wednesday, March 26, 2025 (5:00 P.M.), the voting portal of the service provider was blocked forthwith.



- 4. After transacting the business at the meeting, the Chairman ordered for Poll for those members who could not cast their vote through remote e-voting with the assistance of the Scrutinizer.
- 5. Immediately after the conclusion of the polling process at the venue of the EGM on the 27th day of March, 2025, the votes cast at the venue were counted, thereafter the votes cast through remote evoting were unlocked on Friday, the 27th day of March, 2025 around 5:30 P.M.
